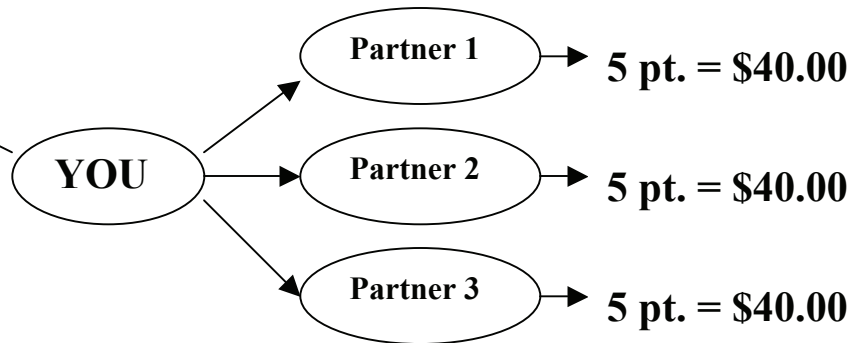

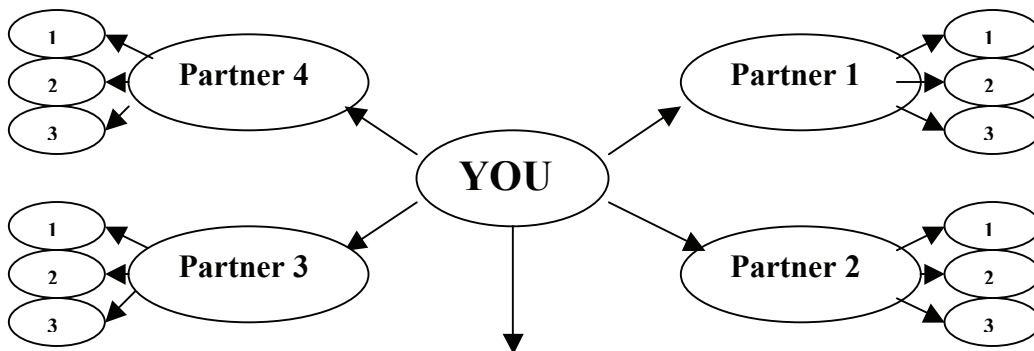

One Example of Building a Network



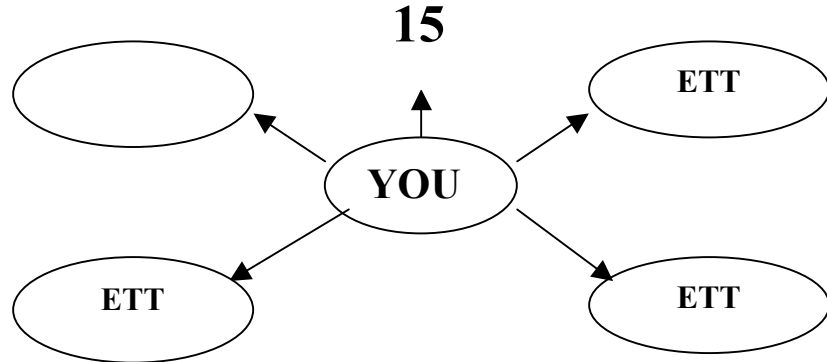

NOTICE OF CANCELLATION
